Stefano Maffei (Ph.D. Oxford) is Lecturer in criminal procedure in Parma. An expert in the law of the European Court of Human Rights, Stefano is the author of several publications in international journals and the report on "Italian criminal justice" in the *European Journal of Criminology* (2007, pp 461-482) and in the Encyclopedia *Crime and Punishment Around the World* (Newman ed, 2010).

Ignacio Borrajo Iniesta is a spanish distinguished expert in Constitutional and Administrative law. Ignacio is currently serving as a senior research officer (*Letrado*) at the Constitutional Court of Spain.


